## NATIONAL RIGHT TO WORK LEGAL DEFENSE FOUNDATION

Dear Eric,

Joe Biden is giving America away to Big Labor.

And unless you and I stand up to him, there is no law he will not break or rule he will not overturn to put more money in Union Bosses' pockets.

That's why the story about forced unionism at the Red Rock Casino made my blood boil.

You see, the Red Rock Casino in Las Vegas employs hundreds of workers who depend on their paychecks to make ends meet for their families.

But Union Bosses lust for a cut of their money.

And Joe Biden lusts for Big Labor's money to get re-elected in 2024.

So the Union Bosses were certain that they could have their way with the workers of Red Rock Casino.

But a surprising thing happened (surprising to Biden and the Union Bosses, that is).

When Big Labor tried to swoop in and unionize them by force, and in the process take massive dues out of their paychecks, the workers of the Red Rock Casino voted "No!"

They had no interest in Big Labor coming in and taking away a substantial part of their livelihood. They told the Union Bosses to get lost by a vote of 627-534.

And do you know what the Union Bosses did? They ignored the election results and helped convince a controversial Harry Reid-selected judge to force the workers into the union anyway.

The Judge, a woman named Gloria Navarro, ruled that the workers' vote would be nullified and the union installed as the employees' so-called "representative" based on claims by union organizers that enough of the workers had previously signed union authorization cards.

Of course, do you really think the workers signed all those cards willingly and voluntarily -- or under duress?

The fact that they voted overwhelmingly against unionization when the ballot was secret from the prying eyes of union agents should answer that question definitively.

But the Biden-controlled National Labor Relations Board (NLRB) smiles at the overturning of elections that don't go Big Labor's way...and even plots to impose Card Check forced-unionism across America.

If this ruling holds up, you can expect Left-wing Judges across America and the union-label NLRB to use this same

contorted logic to hand the Union Bosses more power.

That's why your action is needed at once.

Of course, the Biden Administration, which continually claims to protect workers' rights, instead backs Big Labor 100%.

Now, they want to expand this process to force millions more workers under Big Labor's thumb, and pump billions of dollars more into Union Boss coffers.

The message to these workers is clear -- give us your money, or lose everything.

When I heard this story, I knew we had to do something about it.

That's why the National Right to Work Foundation has stepped up to the plate, with Foundation attorneys filing numerous briefs defending these workers at the Ninth Circuit Court of Appeals.

But as you can imagine, Big Labor shells out big money to defeat us in cases like these, where the Foundation is aiding workers opposed to unionization.

Using forced dues money, they can pay for the most expensive lawyers they can get their hands on.

In order to keep up with Big Labor's legal onslaught designed to radically expand their Card Check powers, I need Right to Work supporters like you to stand with these workers and contribute to your Foundation.
